
## **PRESS RELEASE**

In our previous Press Release (PR-1) we provided links to Amy Sherlock's Motion to Vacate a Void anti-SLAPP Judgment filed May 9, 2024, in San Diego Superior Court. This motion was based in large part on recent findings of systemic pay-to-play corruption in the City of San Diego's adult-use cannabis licensing processes. It was also based on one of the defendants ADMITTING to this corruption and providing evidence of it as well as new forensic evidence which provides proof that Amy Sherlock's husband, Biker, the licensee of record on not one but two of these highly sought after licenses, (according to one of the nation's leading crime scene investigators) who concluded Biker definitely did not die by suicide but rather was murdered.
